Network Change Summary:			
<p>This change is a result of road improvements to Highland Green Blvd. by Butler County. Widening of the road will cover up the existing plant and require the removal of a 2700 SAC. Copper facilities that feed the Woodbridge Apts. on Highland Green, west of Cincinnati-Dayton Rd will be removed and the existing customers (14) will be transferred to the fiber facilities that are already in place.</p>			
Description of type of changes planned:			
Description of Reasonably Foreseeable Impact of the Planned Changes:			
<p>Two F2 cables(900 PAIR & 400 PAIR) will be retired and removed and the existing 48 fibers will be rerouted outside of the construction area by conduit previously installed for this project. The span extends from a manhole at the corner of Cincinnati-Dayton Rd. and Highland Green Drive to just inside the entrance of Woodbridge Apts. The F2 cables extending from SAC to the apts. and within the apt. complex will be retired and removed.</p>			

After the copper distribution facilities are retired and removed, Cincinnati Bell will no longer offer copper-based UNEs. To the extent required by applicable agreements and federal law, Cincinnati Bell will offer to requesting carriers a 64kbps voice grade channel over fiber loops that have been deployed where copper loops have been retired.
